- Prepare the Solvency II files and reconciliations relating to investments using programming languages (RStudio, potentially Python at a later stage),
- Identify opportunities to improve the quality of reports produced as well as to achieve process efficiency, while using Excel and programming capabilities,
- Actively support transition between old and new investment administration systems, including managing data enhancement, reconciliations, and cleaning, ensuring proper data administration in the new environment, co-designing reports answering the current reporting and information sharing demands regarding investment assets,
- Provide in-depth analysis of the Atradius investment portfolio,
- Liaise with internal and external parties providing information on investments,
- Liaise with various stakeholders in adapting internal systems and processes to the changes within the investment portfolio, in line with the EIOPA updates and IFRS regulations.
